Composting and Yard Waste in Woodbrook

If Woodbrook residents have compost for collection place it curbside for collection on Wednesday to be picked up by the Evergreen lawn crew. Collection of large branches and other yard waste is currently under review. More information to follow.

Another option for residents with City of Bozeman garbage collection is to put compost and yard clippings in clearly marked plastic or metal cans or brown paper compostable bags or open plastic bags. Place yard clippings and compost out and ready for pickup no later than 7 am on Wednesday next to your garbage. Bozeman collects grass clippings, leaves, small branches (pencil diameter or smaller), and garden waste.

Dogs and Cats

More and more Woodbrook owners are enjoying the companionship of a dog or cat. Owners/guests are reminded:

Dogs must be walked on a leash

Owners/ guests must immediately clean up all droppings

Pets shall not be tied up and left unattended.

The City of Bozeman Ordinance requires that dogs and cats over the age of 6 months be licensed annually. This requires proof of vaccination
