

Winter Parking and Snow Removal

It's February and we are starting to see more snowfall in Bozeman. While it's about time, it does cause some changes in Woodbrook that we all need to remember. The areas designated for Guest Parking often become the areas for our snow removal crew to store snow piles on-site. Storage of snow, however, results in fewer parking places available in Guest Parking. We ask that owners and visitors not leave cars for long periods in Guest Parking. Vehicles can interfere with needed snow removal and storage. If you have guests who are using the Guest Parking spaces, please be mindful of the weather and ask them to move their cars so that the snow can be cleared.

The freeze/thaw cycles that we have experienced so far this winter have contributed to slippery walking surfaces in Woodbrook. To address this, the snow removal company focused on some particularly concerning areas with ice melt and hand shoveling. In addition, Cindy from Echo Property Management met with Joe to come up with more ideas to mitigate some of the slippery surfaces.
